In terms of Notification No.76-RG dated 16.01.2014 and subsequent Notification No.188-RG dated 16.01.2017, the re-examination of the candidates who appeared in the written test on 08.06.2014 and not disqualified, was held on 05.03.2017 followed by viva-voce of 206 provisionally selected candidates on 06.05.2017.
