The Roster/Determination of Appellate Side, Original Side and Commercial Division of this Hon'ble Court, notified vide Notification No. 10404-RG dated 9th November, 2023, is partially modified to the following extent and will take effect from 5th March, 2024:-

Hon'ble Justice Arindam Mukherjee (SB-VII), shall take up the following matters:-

* Matters (motion & hearing) under Article 226 of the Constitution of India relating to Labour and Industrial Legislation under Group-III including applications connected thereto.

Hon'ble Justice Sugato Majumdar (SB-XVII), shall take up the following matters:-

* Both interlocutory applications / motion and hearing of Suits including IPR [Except Suits and proceedings relating to Testamentary and Intestate Jurisdiction and the matters assigned to other Bench(s)] (Upto 2015).

Hon'ble Justice Krishna Rao (SB-XIX), shall take up the following matters:-

* Both interlocutory applications / motion and hearing of Suits including IPR [Except Suits and proceedings relating to Testamentary and Intestate Jurisdiction and the matters assigned to other Bench(s)] (From 2016).

Hon'ble Justice Partha Sarathi Chatterjee, shall take up the following matters whenever His Lordship sits single:-

* Hearing of Writ Petitions upto year 2014 and applications connected thereto;

* Hearing of Criminal Appeals upto year 2010 and applications connected thereto.

All other subject matters, pertaining to the roster/determination of the Hon'ble Judges, which are in effect as on date, shall remain unchanged.
