The sealed tender will be opened on **01/02/2018 at 12 noon**.
2. Quotations should be submitted in sealed envelope with superscripted in it.
3. Rates should be quoted indicating price / unit and should be inclusive of all additional charges.
4. Willing suppliers submitting Quotations should know that the Hon'ble Court may procure **such quantity of listed articles** as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the State Legal Services Authority, 2&3, Kiran Sankar Roy Road, 1st Floor, City Civil Court Building, Calcutta-700001.
