Sub:- Direction of the Hon'ble Court for immediate release of charge of officers who are under order of transfer vide Hon'ble Court's Notice dated 07.08.2024 and 24.09.2024

Sir/Madam,

I am directed to refer to the Notice dated 07.08.2024 and 24.09.2024 published in Court's website regarding Transfer/Promotional Posting of Officers in different cadres of the WBJs and to inform that the Hon'ble Court has taken due note of the fact that a number of officers have still preferred not to deliver charge of their Court and Office inspite of passing of a considerable period of time since issuance of their Transfer Notification and therefore, **directed the concerned officers to deliver charge of their respective Court and Office by 18.11.2024 (Monday) and those would not be delivering charge shall be deemed to be released from their present place of posting w.e.f. the afternoon of 19.11.2024 (Tuesday).**
