- (6) Smt. Paulami Pandit, Judicial Magistrate, 5th Court, Krishnagar, Nadia U.O.T. as Civil Judge (Junior Division), 1st Court, Barasat, North 24-Parganas** is directed to deliver charge by 30.11.2024 (A/N), failing which she will be deemed to be released w.e.f. 02.12.2024 (A/N).
- (7) Smt. Sujata Mondal, Judicial Magistrate, 7th Court, Alipore, South 24-Parganas U.O.T. as Civil Judge (Junior Division), Additional Court, Lalbagh, Murshidabad** is directed to deliver charge by 26.11.2024 (A/N), failing which she will be deemed to be released w.e.f. 27.11.2024 (A/N).

The Hon'ble Court has also been pleased to direct that the officers succeeding Sri Deepto Ghosh and Smt. Debarpita Tarafder i.e. Smt. Mandakranta Saha, Sri Asis Kumar Mukherjee and Smt. Pratika Rai in the particular chain of transfer to deliver charge of their present assignment by 26.11.2024 (A/N) failing which they shall be deemed to be released w.e.f. 27.11.2024 (A/N).
